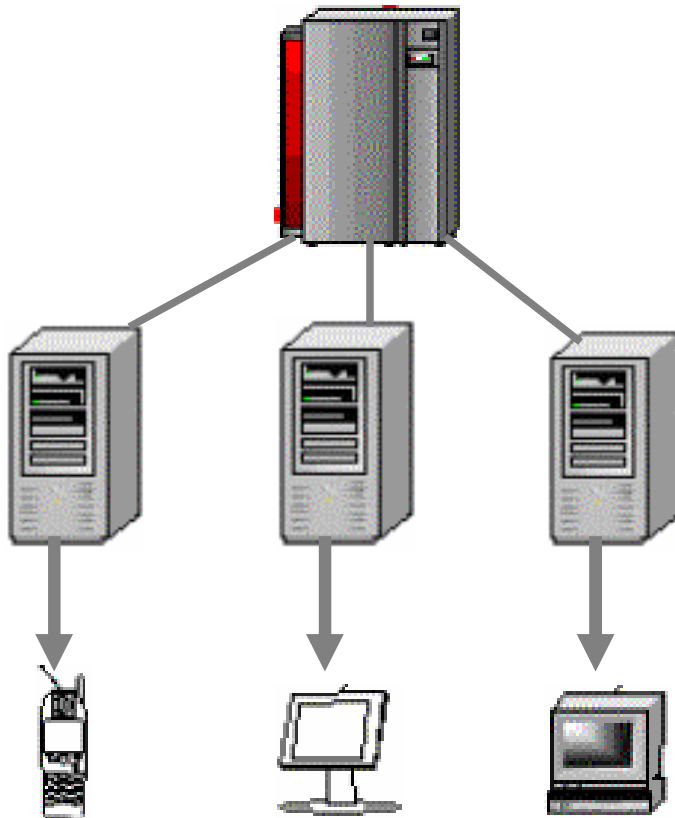
Pacific Lottery Corporation

Pacific Lottery Corporation (PLC) is a publicly traded company on the Canadian TSX-Venture Exchange . PLC was incorporated in 1995 by articles of incorporation under the Business Corporations Act (Alberta). The principal business of the Corporation is to research, develop, manufacture, operate and manage on-line lottery central systems. PLC's focus is to supply technology and accompanying services for the proper conduct of jurisdictional wide on-line lottery operations.

PLC has set up under exclusive contract with the Vietnamese authorities, one of Asia's most populated and economically vibrant countries, a modern electronic online lottery program. The Corporation is currently engaged in expanding this program and is contracted to supply the Vietnamese Government with additional proprietary central system equipment, hardware, software and accompanying lottery terminals, as well as provide the training and marketing support that is required for the implementation and proper operation of a National modern online electronic lottery program (similar to North American 6/49 & Powerball lotteries) throughout Vietnam.

The Corporation has a regional office in Hanoi where the local staff has been conducting various activities, which are required to ensure the successful implementation and ongoing operation of a Vietnamese lottery program. As well, the local staff has undergone extensive training in various aspects of lottery operation, including but not limited to, computer operations, field service and bench repair, hot line service, marketing and promotion.

Central System & Security



- The PLC Central System operates on secure LAN/LED networks to communicate with PLC Terminals at retailer locations
- The Central System operates with various communication infrastructures such as X.25 or TCP/IP Protocols and can support up to 100,000 transactions per second
- PLC Software is proprietary and implements:
 - Transactions via terminals
 - Retailer management
 - Calendar management
 - Fraud prevention and detection
 - Terminal application version management
 - Mobile phone accessibility
- License: source codes are owned exclusively by PLC
- Security: the risk of breaching, pirating or reverse engineering the software is minimal due to the scope, size, cost and complexity of the task

PLC's Gold Lottery Terminal is proprietary:

- solution for high volume online lottery ticket sales
- Rapid printing, a high-speed processor and fast capture of bet slips, tickets or “scratchers”
- Internal laser bar code scanner automatically recognizes and validates lottery tickets or instant games
- A touch screen and an ergonomically designed graphic user interface simplifies the sales task
- Transaction integrity is ensured by using encryption to secure its communication with the lottery central system
